

presents the following Ordinance:

CAPITAL ORDINANCE APPROPRIATING \$2,000,000 FROM THE CAPITAL IMPROVEMENT FUND TO PAY FOR REPAVING OF STREETS IN THE CITY OF TRENTON, IN THE COUNTY OF MERCER, STATE OF NEW JERSEY

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE CITY COUNCIL OF THE CITY OF TRENTON, IN THE COUNTY OF MERCER, STATE OF NEW JERSEY (a majority of the full membership thereof affirmatively concurring), AS FOLLOWS:

SECTION 1. The capital purposes described in Section 2 of this capital ordinance are hereby authorized as general capital purposes to be undertaken by the City of Trenton, in the County of Mercer, State of New Jersey (the "City"). For the said improvements or purposes stated in Section 2 hereof, there is hereby appropriated the sum of \$2,000,000, said sum now being available in the Capital Improvement Fund of the City.

SECTION 2. The improvements and purposes hereby authorized are to provide for Repaving of Streets. The improvements and purposes shall also include, but are not limited to, as applicable, all work, materials, equipment, labor and appurtenances necessary therefor or incidental thereto.

SECTION 3. The expenditure of \$2,000,000 from the Capital Improvement Fund of the City for the purposes set forth in Section 2 hereof is hereby authorized and approved.

ORDINANCE

SECTION 4. The City hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

SECTION 5. This Ordinance shall take effect 20 days after the first publication hereof after final adoption, as described in N.J.S.A. 40:69A-181.
