**RESOLUTION ACCEPTING A BID AND AWARDING A CONTRACT TO
HUTCHINS HVAC, INC., FOR MAINTENANCE OF HVAC SYSTEM FOR THE
DEPARTMENT OF WATER AND SEWER, WATER UTILITY DISTRIBUTION
COMPLEX FROM JUNE 3, 2022 TO DECEMBER 31, 2022
IN AN AMOUNT NOT TO EXCEED \$59,035.00 BID 2022-36**

WHEREAS, seven (7) sealed bids were received on April 22, 2022 for maintenance of HVAC systems at 333 Cortland Street for the City of Trenton, Department of Water and Sewer, Water Utility Distribution Complex; and

WHEREAS, this contract is for the necessary maintenance of the Heating Ventilation and Air Conditioning System for Trenton Water Works Distribution Complex; and

WHEREAS, the low bidder, Hutchins HVAC, Inc, 601 Union Avenue, Union Beach, NJ 07735 in made pursuant to advertisement, be and is hereby accepted, as the lowest, responsive, responsible bidder complying with the terms and specifications on file in the Division of Purchasing; and

The City of Trenton shall award this contract from June 3, 2022 to December 31, 2022 in an amount not to exceed \$59,035.00; and
