**RESOLUTION ACCEPTING A BID AND AWARDING A CONTRACT TO
ALS GLOBAL FOR LABORATORY ANALYSIS, TESTING AND
MONITORING TO ENSURE SAFE DRINKING WATER AND REGULATORY
COMPLIANCE FOR A PERIOD OF ONE (1) YEAR FROM AUGUST 5, 2022 TO
AUGUST 4, 2023 FOR WATER FILTRATION PLANT IN AN AMOUNT NOT
TO EXCEED \$56,736.00 BID2022-40**

WHEREAS, three (3) sealed bids were received on May 17, 2022 for Laboratory Analysis, Testing and Monitoring to ensure safe drinking water and regulatory compliance for a period of one (1) year with an option to extend one (1) for the City of Trenton, Department of Water and Sewer, Trenton Water Works, Water Filtration Plant; and

WHEREAS, the low bidder, Eurofins Eaton Analytical, LLC, cannot fulfil the lab analysis requirements, due to required testing within sample hold times, samples would have to be shipped overnight to their laboratory which may cause delay in analyzing the samples within the allotted time frame. Failure to have water testing samples analyzed within required time frame; Trenton Water Works could be at potential risk of non-compliance with the State of New Jersey; and

WHEREAS, the second low bidder, ALS Global, 301 Fulling Mill Road, Middletown, PA 17057 in made pursuant to advertisement, be and is hereby accepted, as the lowest responsive, responsible bidder complying with terms and specifications on file in the Division of Purchasing; and

WHEREAS, funds in an amount not to exceed \$56,736.00 for a period of one (1) year have been certified to be available in the following account number: 02-05- -55-5500-824-003, with an option to extend one (1) year \$56,736.00. The City of Trenton shall award this contract from August 05, 2022 to August 04, 2023; and


