RESOLUTION AUTHORIZING TO RESCIND RESOLUTION #21-518 AND CANCEL THE CONTRACT AWARDED TO SHANNON CHEMICAL CORPORATION FOR THE FURNISH AND DELIVERY OF ZINC ORTHOPHOSPHATE CONTRACT AND PURCHASE THROUGH GEORGE S. COYNE ON AN EMERGENCY BASIS-BID 2021-62

WHEREAS, Resolution #21-518 was awarded on November 19, 2021, to Shannon Chemical Corporation, P.O. Box 376 Malvern, PA 19355; for the furnish and delivery of Zinc Orthophosphate for a period of (1) one year in an amount not to exceed \$134,658.70 at \$1,224.17 per ton; and

WHEREAS, Shannon Chemical Corporation breached contract by refusing to deliver the chemical Zinc Orthophosphate at the contracted price; and

WHEREAS, Trenton Water Works advised Shannon Chemical Corporation that the contract would be terminated for non-compliance; and

WHEREAS, Zinc Orthophosphate is used for corrosion control treatment for high service customers fed from the Central Pumping Station in the distribution system. The purpose of this chemical is to coat piping in the distribution system to prevent lead from leaching into the water going through the customers tap; and

WHEREAS, it is in the best interest of the City of Trenton to rescind Resolution #21-518 and cancel the contract awarded to Shannon Chemical Corporation, and the Department of Water & Sewer has obtained a quote from George S. Coyne Chemical Company, P.O. Box 536258, Pittsburgh, PA 15253 in an amount of \$22,096.42 for the purchase of Zinc Orthophosphate.

WHEREAS, funds in an amount not to exceed \$22,096.42 have been certified to be available in the following account number: 02-05- -55-5500-821-016.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to rescind Resolution #21-518 and cancel the contract awarded to Shannon Chemical Corporation, P.O. Box 376, Malvern, PA 19355; for said purposes in the manner prescribed by law.
