This Agreement, entered into this 15th Day of DECEMBER 2022 between the City of Trenton, a municipal corporation of the State of New Jersey, ('CITY') **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** and **PROCOPS SECURITY, LLC, 60 PARK PLACE, SUITE 1110, NEWARK, NEW JERSEY 07102** (Contractor"), witnesseth that:

WHEREAS, Resolution No. #21-451, awarded a contract on October 7, 2021, to ProCops Security, LLC, 60 Park Place Suite 1110, Newark, New Jersey 07102 to provide armed security guard services to Trenton Water Filtration Plant in an amount not to exceed \$253,344.00 (for 24 hours, 7 days per week at \$29.00 per hour) for a period of one (1) year from October 8, 2021 to October 7, 2022; with an option to extend one additional (1) year (for 24 hours, 7 days a week at \$30.00 per hour) from October 8, 2022 to October 7, 2023 for the City of Trenton, Department of Water and Sewer, Water Filtration Plant; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and


