RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR AN ADDITIONAL ONE (1) YEAR AWARDED TO SCOTT TESTING, INC. FOR INSPECTION TESTING, PREVENTATIVE REPAIR MAINTENANCE OF PRIMARY AND SECONDARY EQUIPMENT AT THE TRENTON WATER FILTRATION PLANT FROM DATE OF AWARD IN AN AMOUNT NOT TO EXCEED \$135,528.00 - BID 2021-76

WHEREAS, on January 20, 2022, Resolution No. 22-019 awarded a contract to Scott Testing, Inc, 245 Whitehead Road, Hamilton, New Jersey 08619-3250 for Inspection, Testing, Preventative Repair Maintenance of Primary and Secondary Electrical Equipment for a period of one (1) year in an amount not to exceed \$137,148.00 with an option to extend one (1) additional year in an amount not to exceed \$135,528.00 for the City of Trenton, Department of Water and Sewer, Water Filtration Plant; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Water and Sewer, Water Filtration Plant, has determined that Scott Testing, Inc, 245 Whitehead Road, Hamilton, New Jersey 08619-3250 for Inspection, Testing, Preventative Repair Maintenance of Primary and Secondary Electrical Equipment performed services in a satisfactory manner and it is in the best interest of the city to exercise the option to extend the contract for an additional one (1) year from time of award; and

WHEREAS, funds in an amount not to exceed \$135,528.00 have been certified to be available in the following account number: 3-05- -55-5506-823-002. The City of Trenton shall award this contract for an additional one (1) year from time of award.

WHEREAS, one (1) sole bid was received on November 8, 2021 for Inspection, Testing, and Preventive Repair Maintenance of Primary and Secondary Electrical Equipment for a period of one (1) year with an option to extend one (1) additional year from date of award for the City of Trenton, Department of Water and Sewer, Trenton Water Filtration Plant; and

CONTRACT EXTENSION
WITH SCOTT TESTING, INCORPORATED
BID2021-76**

THE AGREEMENT made this 10TH day of MARCH 2023, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **SCOTT TESTING, INCORPORATED, 245 WHITEHEAD ROAD, HAMILTON, NEW JERSEY 08619** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 22-019 awarded a contract on JANUARY 20, 2022, to Scott Testing, Incorporated, 245 Whitehead Road, Hamilton, New Jersey 08619 for inspection, testing, and preventative repair maintenance of primary and secondary electrical equipment for a period of one (1) year in amount not to exceed \$137,148.00 per year from January 21, 2023 to January 20, 2024 with the option to extend one (1) additional year in an amount not to exceed \$135,528.00 for the City of Trenton, Department Water and Sewer; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, the City of Trenton, Department of Water has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for an additional one (1) year to Scott Testing, Incorporated, 245 Whitehead Road, Hamilton, New Jersey 08619 in an amount not to exceed \$135,528.00 from January 21, 2023 to January 20, 2024; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be funds in an amount not to exceed \$135,528.00 for the City of Trenton, Department of Water and Sewer from January 21, 2023, to January 20, 2024.
2. The Mayor is hereby authorized to enter into a contract extension for an additional one (1) year from January 21, 2023 to January 20, 2024 with Scott Testing, Incorporated, 245 Whitehead Road, Hamilton, New Jersey 08619 in an amount not to exceed \$135,528.00 for the inspection, testing, and preventative repair maintenance of primary and secondary electrical equipment for the City of Trenton, Department of Water and Sewer, Water Filtration Plant for the said purposes in the manner prescribed by law.
