**RESOLUTION AUTHORIZING PAYMENT FOR A CONTRACT WITH  
GEORGE S. COYNE CHEMICAL COMPANY, 3015 STATE ROAD, CROYDON  
PA 19021-6997 WHICH WAS AWARDED ON AN EMERGENCY BASIS FOR  
THE PURCHASE AND DELIVERY OF POTASSIUM PERMANGANATE FOR  
THE CITY OF TRENTON, DEPARTMENT OF WATER AND SEWER, WATER  
FILTRATION PLANT IN AN AMOUNT NOT TO EXCEED \$93,739.20**

WHEREAS, a contract was awarded to George S. Coyne Chemical Co., for the emergency purchase and delivery of a three month supply of Potassium Permanganate for the City of Trenton, Department of Water & Sewer, Trenton Water Works, Water Filtration Plant and

WHEREAS, the maximum amount of the contract was \$93,739.20 and funds have been certified to be available in operating account 03-05- -55-5506-821-012; and

WHEREAS, the Local Public Contracts Law at N.J.S.A. 40A:11-6 provides that "[a]ny contract may be negotiated or awarded . . . without public advertising for bids and bidding therefore, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety and welfare requires the immediate . . . performance of services", subject to the award being made pursuant to the manner set forth therein; and

WHEREAS, the official in charge M. Sean Semple. - Acting Director of Water & Sewer, submitted the attached certification that an emergency existed, and that immediate services to remedy the emergency were required.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Trenton, in the County of Mercer as follows:

1. The Mayor is hereby authorized to provide for payment in the amount of \$93,739.20 to George S. Coyne Chemical Co., Croydon, PA 19021-6997 for the emergency purchase and delivery of a three month supply of Potassium Permanganate.
2. This contract was awarded without competitive bidding as an emergency pursuant to N.J.S.A. 40A:11-6 of the Local Public Contracts Law.
3. A notice of this action shall be printed once in the official newspaper for the City of Trenton, and the resolution and contract shall remain on file in the City Clerk's office.
4. The Emergency Procurement Report shall be filed with the Director of the Division of Local Government Services within 30 days pursuant to N.J.S.A. 19:44A-20.12.

**AGREEMENT  
RESOLUTION #23-228  
PAYMENT FOR EMERGENCY PURCHASE AND DELIVERY OF POTASSIUM PERMANGANATE FOR THE CITY OF TRENTON,  
DEPARTMENT OF WATER AND SEWER, WATER FILTRATION PLANT  
ISSUED TO GEORGE S. COYNE CHEMICAL COMPANY**

**THE AGREEMENT** made this 5<sup>TH</sup> day of MAY 2023, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **GEORGE S. COYNE CHEMICAL COMPANY, 3015 STATE ROAD, CROYDON, PENNSYLVANIA 19021** (hereinafter "CONTRACTOR")

**WHEREAS**, a contract was awarded to George S. Coyne Chemical Company, 3015 State Road, Croydon, Pennsylvania 19021, for the emergency purchase and delivery of Potassium Permanganate for the City of Trenton, Department of Water and Sewer, Trenton Water Works, Water Filtration Plant; and

**WHEREAS**, the Local Public Contracts Law at N.J.S.A. 40A:11-6 provides that "[a]ny contract may be negotiated or awarded...without public advertising for bids and bidding therefore, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety, and welfare requires the immediate... performance of services", subject to the award being made pursuant to the manner set forth therein; and

**WHEREAS**, the official in charge acting Director Sean Semple, submitted the attached certification that an emergency existed, and that immediate services to remedy the emergency were required.

**NOW THEREFORE**, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$93,739.20 awarded to George S. Coyne Chemical Company, 3015 State Road, Croydon, Pennsylvania 19021 for the emergency purchase and delivery of Potassium Permanganate for the City of Trenton, Department of Water and Sewer, Trenton Water Filtration Plant.
2. The Mayor is hereby authorized to execute an emergency payment in an amount not to exceed \$93,739.20 to George S. Coyne Chemical Company, 3015 State Road, Croydon, Pennsylvania 19021 for the emergency purchase and delivery of Potassium Permanganate for the City of Trenton, Department of Water and Sewer, Water Filtration Plant for the said purposes in the manner prescribed by law.


