VI. Cost Criteria

Off Duty Management's (ODM) transparent fee structure is all-inclusive of the services described in this RFP response. These fees are charged directly to the private business customer requesting off-duty details. The City of Trenton, Trenton PD, and its officers will never be charged any fees or costs for ODM's comprehensive administrative services, technology, or insurance. In addition, the City, agency, and your customers pay nothing for implementation, training, or onboarding. ODM manages all invoicing and collections and remits payments directly to the City of Trenton.

A. Pricing

- Our administrative fee of \$5.00 per hour will be added to each officer's hourly rate.
- Upon contract award, this fee will be converted to a percentage.
- Our fee is all-inclusive, no hidden costs, fees, or add-ons.
- Our administrative fee includes all costs ODM charges to the customer.
- Credit card processing fees are included as a separate line item on the total invoice.
- Credit card processing fees are a direct bank cost and are not marked up by ODM.

SECTION 7. FEE

EDS levies a 7.75% fee for all extra duty work, not to include any City fees. This fee is charged to the customer (whoever is paying for the detail). EDS does not charge for program configuration, in-person training, implementation, training, travel, or insurance. This fee structure is valid for five years. EDS does not levy extra fees to vendors for up front/escrow payments or payments by check. Nor do we charge the full scheduled fees on detail modifications or cancellations -- just any cancellation hours minimum the officers and City charges.

Customers paying by credit card will be charged an additional 3.0% fee.

EDS also offers fully-integrated on-duty scheduling software with full integration between on- and off-duty schedules. Our on-duty scheduling software has been used for more than 20 years by agencies as large as Charlotte Mecklenburg, NC and the United Nations.

If the Trenton Police Department would like to use our on-duty scheduling software, we can include full set-up, use and hosting of that software for an additional 1% increase to our administration fee. If there is interest, we can install that software anytime.
