Active Environmental Technologies, Inc. (Active) is pleased to provide pricing for the following scope of work at the above referenced property.

**1.0 Scope of Work Task II Monitoring Well Installation**

Active will also provide the 78DT Geoprobe®, licensed NJ driller and apprentice to install four 2-inch groundwater monitoring wells. Prior to the installation of two of the wells, two soil borings will be installed to a depth of 10 foot below ground surface (bgs) to classify soils.

Following the installation of the soil borings, Active will install the wells. Each well will be installed to approximately 20 feet (bgs) utilizing the hollow stem auger method of installation. The wells will be constructed with schedule 40 pvc screen and riser and will be completed with a flush mount lid and locking cap. Active will perform this scope of work in two day. Active will place the NJ Dig notification, as well as acquire the appropriate monitoring well permits.




