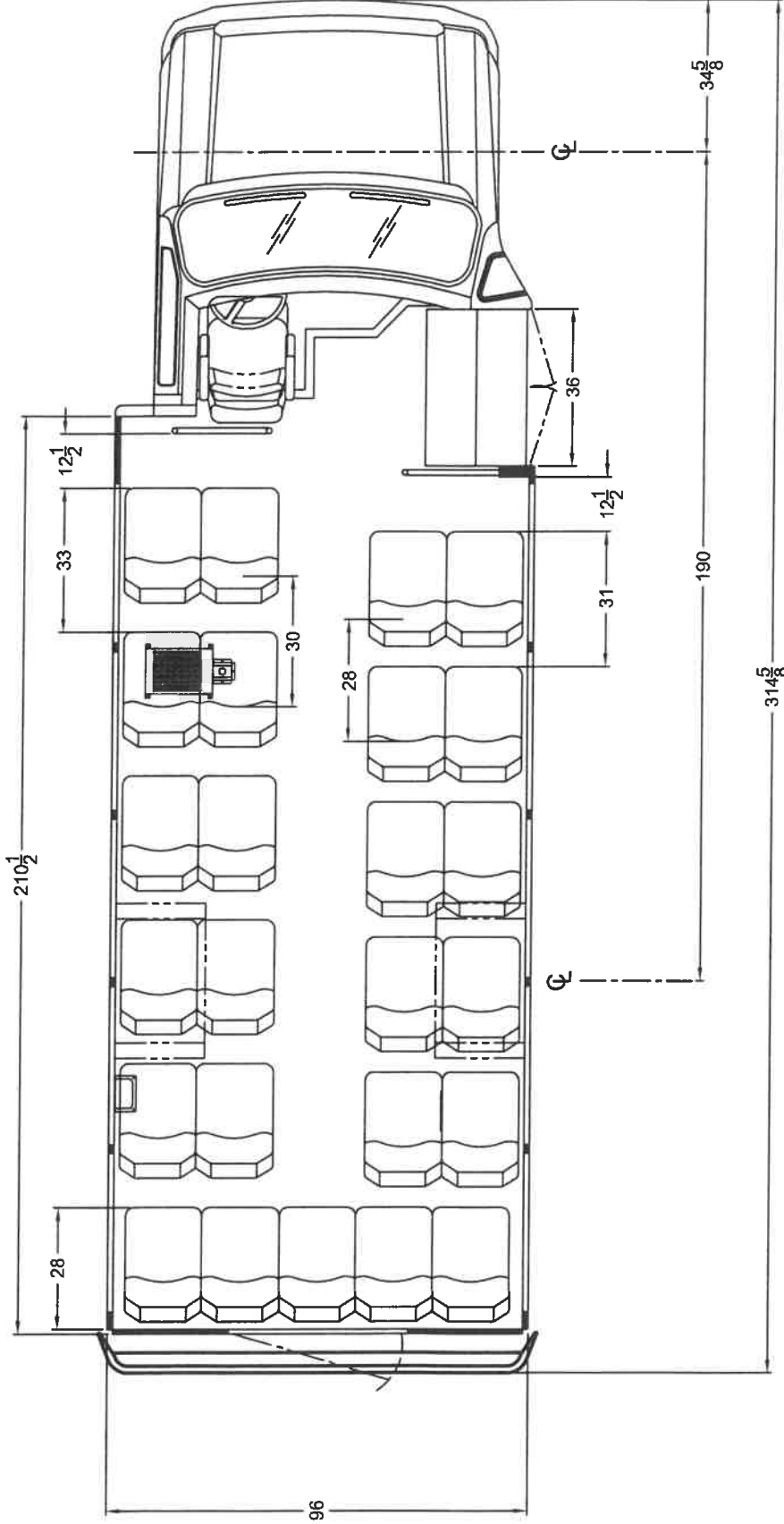
Service Facility:

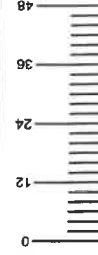

Due to the short delivery of 30 days, Model 1 is bidding a stock unit that has exceptions.

The following items are not included - A master disconnect switch, Large heavy duty running board, front mud flaps, instep battery box, center mount third brake light, rear emergency door, overhead grab rail on street side, exterior mounted key lock for passenger door, driver's door speaker, electric heated entry step, and will be on a 2024 E450 chassis.

Exterior mirrors will be manual and not the requested heated/remote.

Ground to first step will be 12.5" instead of the requested 11".

Passenger step well will not be galvanized 11 guage steel.

Turn signals will be red and not the requested amber.

The rear wall will have an emergency window and not the requested emergency door nor twin windows located to either side of the door opening.

There will be no yellow standee line. Step nosing will be white instead of yellow.

Interior mirror will be a convex 6" x 9" mirror instead of 6" x 16" flat mirror.

Rear heater will be a single 70K BTU heater instead of the requested two 40K BTU heaters.

Our heater will have a heater booster pump.

Rear AC will be a ceiling mounted evaporator instead of an in wall evaporator.

Interior sidewalls and ceiling will be an upgraded padded black vinyl.

Interior floor covering will be an upgraded Gerfor Gaya Wood 4821 Yellowstone in lieu of graphite black.

Passenger seats will be Freedman High back seats. All seats will recline except for the last row. Seats will also have upgraded retractable seatbelts, seat covering to be upgraded level 5 black milano vinyl, and upgraded vertical stitching. The seats will not have the requested padded grab handles on the seat backs. There will be an upgraded feature of 10 Power Outlets in passenger compartment that will have a 110V outlet and 2 USB ports.

Outlets will be powered by a 3000W 110 inverter.

Interior overhead luggage racks will be on both streetside and curbside of the bus. These luggage racks will have a total of 12 dual reading lights mounted on the underside of the overhead luggage racks.

Also provided will be a upgraded metal fuel locking door.

Morryde RS suspension system will be provided for ride enhancement.

Plywood sub floor will be 5/8" Marine Grade plywood and not the requested Marine Tech plywood.

Our location is not in the requested 25 mile range. Our service facility is 66.9 miles.
