



**RESOLUTION AUTHORIZING AN EMERGENCY PAYMENT TO YARDLEY ANIMAL KENNELS, INC WHICH WAS AWARDED ON AN EMERGENCY BASIS FOR EMERGENCY DOG BOARDING FOR THE CITY OF TRENTON ANIMAL SHELTER, IN AN AMOUNT NOT TO EXCEED \$274,155.00.**

WHEREAS, Yardley Animal Kennels, Inc, 1085 Reading Avenue, Yardley, Pennsylvania is boarding dogs for The Trenton Animal Shelter, on an emergency basis; and

WHEREAS, State rules require the impoundment of stray dogs or other animals observed by an Animal Control Officer to be ill, injured, or creating a threat to public health; and

WHEREAS, there are 65 dogs at the Trenton Animal Shelter and 43 dogs at Yardley Animal Kennels; and

WHEREAS, the maximum amount of the contract was: \$496,569.94 and funds have been paid in full. Additional funding is necessary to cover additional expenses for services in the amount of \$274,155.00 certified to be available in account numbers T-12-DL-40-2101-001, 0T-12-DL-40-2102-001, T-12-DL-40-2103-001, T-12-DL-40-2210-001, T-12-DL-40-2210-002, 4-01- 40-4030-299, T-12-DL-40-2202-001-; and

WHEREAS, the Local Public Contracts Law at N.J.S.A 40A:11-6 provides that "any contract may be negotiated or awarded...without public advertising for bids and bidding therefore, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting public health, safety, and welfare requires the immediate...performance of services", subject to the award being made pursuant to the manner set forth therein; and


**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton as follows:


1. The Mayor is hereby authorized to provide an emergency payment in the amount not to exceed \$274,155.00 to Yardley Animal Kennels, Inc., 1085 Reading Avenue, Yardley, Pennsylvania for emergency dog boarding services.
2. This contract is awarded without competitive bidding as an emergency pursuant to N.J.S.A 40A:11-6 of the Local Public Contracts Law.
3. A notice of this action shall be printed in the official newspaper for the City of Trenton, and the resolution and contract shall remain on file in the City Clerk's Office.

**AUTHORIZING A ONE TIME PAYMENT TO YARDLEY ANIMAL KENNELS, INC. FOR EMERGENCY DOG BOARDING FOR THE  
CITY OF TRENTON, DEPARTMENT OF HEALTH AND HUMAN SERVICES**

**THE AGREEMENT** made this 4<sup>TH</sup> day of OCTOBER 2024, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **YARDLEY ANIMAL KENNELS, INC., 1085 READING AVENUE, YARDLEY, PA 19067** (hereinafter "CONTRACTOR")

**WHEREAS**, on October 3, 2024 Resolution No. 24-417 awarded a payment to **YARDLEY ANIMAL KENNELS, INC., 1085 READING AVENUE, YARDLEY, PA 19067** for Emergency Dog Boarding in an amount not to exceed \$274,155.00 for the City of Trenton, Department of Health and Human Services; and


