**RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT AWARDED TO ZOMPARELLI CONTRACTORS LLC, FOR THE CONSTRUCTION OF SIDEWALKS, CURBS AND ADA COMPLIANT RAMPS AS DIRECTED AT VARIOUS LOCATIONS WITHIN THE CITY OF TRENTON BY THE DEPARTMENT OF RECREATION, NATURAL RESOURCES & CULTURE FOR AN ADDITIONAL ONE (1) YEAR FROM NOVEMBER 1, 2024 – OCTOBER 31, 2025 IN AN AMOUNT NOT TO EXCEED \$750,000 – BID2023-59**

**WHEREAS**, on November 2, 2023 Resolution 23-506 awarded a contract to Zomparelli Contractors, LLC, 11 Michael Mccorristin Road, Trenton, New Jersey 08690 for Construction of Sidewalks, Curbs and ADA Compliant Ramps as directed at various locations within the City of Trenton for the Department of Recreation, Natural Resources & Culture for a period of one (1) year in an amount not to exceed \$750,000 for the Department of Recreation, Natural Resources & Culture; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

**WHEREAS**, the Department of Recreation, Natural Resources & Culture has determined that Zomparelli Contractors, LLC, 11 Michael Mccorristin Road, Trenton, New Jersey 08690 has performed in a satisfactory manner, and it is in the best interest of the City to exercise the option to extend for an additional one (1) year from date of award; and

**WHEREAS**, funds in an amount not to exceed \$750,000 have been certified to be available in the following account: R-01- -70-7020-290-; The City of Trenton shall award this contract for an additional one (1) year from November 1, 2024 to October 31, 2025.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Trenton that the Mayor is hereby authorized to exercise the option to extend the contract for an additional (1) year awarded to Zomparelli Contractors, LLC 11 Michael Mccorristin Road, Trenton, New Jersey 08690 in an amount not to exceed \$750,000.


