

RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR TWO (2) YEARS, AWARDED TO KUEHNE CHEMICAL CO., INC. FOR THE SUPPLY AND DELIVERY OF 15% SODIUM HYPOCHLORITE SOLUTION FOR THE TRENTON SEWER UTILITY FOR A PERIOD OF TWO (2) YEARS FROM JANUARY 1, 2025 TO DECEMBER 31, 2026 IN AN AMOUNT NOT TO EXCEED \$1,472,640.00 AT \$736,320.00 PER YEAR - BID 2022-73

WHEREAS, Resolution No. 23-063 awarded a contract on February 23, 2023, to Kuehne Chemical Co. Inc., 86 North Hackensack Avenue, Kearny, NJ 07082, for the Supply and Delivery of 15% Sodium Hypochlorite Solution for the Trenton Sewer Utility in an amount not to exceed \$1,472,640.00 at \$736,320.00 per year for a period of two (2) years with the option to extend the contract for an additional two (2) years for the City of Trenton, Department of Water and Sewer, Sewer Utility; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Water and Sewer has determined that Kuehne Chemical Co. Inc., 86 North Hackensack Avenue, Kearny, NJ 07082 has performed the Supply and Delivery of 15% Sodium Hypochlorite Solution for the Trenton Sewer Utility in a satisfactory manner, and it is in the best interest of the City to extend the contract for two (2) years from January 1, 2025 to December 31, 2026; and

WHEREAS, funds in an amount not to exceed \$1,472,640.00 at \$736,320.00 per year have been certified to be available in the following account numbers: 5-07- -55-5500-290 (\$736,320.00) and 6-07- -55-5500-290 (\$736,320.00).



Inc., 86 North Hackensack Avenue, Kearny, NJ 07082 for the Supply and Delivery of 15% Sodium Hypochlorite Solution for the Trenton Sewer Utility in an amount not to exceed \$1,472,640.00 at \$736,320.00 per year for the City of Trenton, Department of Water and Sewer, Sewer Utility for the said purpose in the manner prescribed by law.

EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR AN ADDITIONAL TWO (2) YEARS
WITH KUEHNE CHEMICAL CO. INC., FOR THE SUPPLY AND DELIVERY OF 15% SODIUM HYPOCHLORITE SOLUTION FOR THE
TRENTON SEWER UTILITY FOR A PERIOD OF TWO (2) YEARS FROM JANUARY 1, 2025 TO DECEMBER 31, 2026 BID2022-73

THE AGREEMENT made this 6th day of DECEMBER 2024, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **KUEHNE CHEMICAL CO. INC., 86 NORTH HACKENSACK AVENUE, KEARNY, NJ 07082** (hereinafter "CONTRACTOR")

WHEREAS, on February 23, 2023, Resolution No. 23-063 awarded a two (2) years contract with the option to extend contract for an additional two (2) years to Kuehne Chemical Co. Inc., 86 North Hackensack Avenue, Kearny, NJ 07082 for the Supply and Delivery of 15% Sodium Hypochlorite Solution for the Trenton Sewer Utility in an amount not to exceed \$736,320.00 per year for the City of Trenton, Department of Water and Sewer, Sewer Utilities; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Water and Sewer, Sewer Utilities, has determined that Kuehne Chemical Co. Inc., 86 North Hackensack Avenue, Kearny, NJ 07082 has provided the Supply and Delivery of 15% Sodium Hypochlorite Solution for the Trenton Sewer Utility in a satisfactory manner and it is in the best interest of the city to exercise the option to extend the contract for an additional two (2) years from January 1, 2025 to December 31, 2026; and

WHEREAS, funds in the amount not to exceed \$1,472,640.00 at \$736,320.00 per year to exercise the option to extend the contract for an additional two (2) years. The City of Trenton shall award this contract from January 1, 2025 to December 31, 2026.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor hereby authorized to exercise the option to extend the contract for an additional two (2) years from January 1, 2025 to December 31, 2026 with Kuehne Chemical Co. Inc., 86 North Hackensack Avenue, Kearny, NJ 07082, in amount not to exceed \$1,472,640.00 at \$736,320.00 per year for the Supply and Delivery of 15% Sodium Hypochlorite Solution for the City of Trenton, Department of Water and Sewer, Sewer Utilities for the said purposes in the manner prescribed by law.




