RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT AWARDED TO TRENTON HEALTH TEAM, INC., FOR ESSENTIAL PUBLIC HEALTH SERVICES FOR THE DEPARTMENT OF HEALTH AND HUMAN SERVICES FOR A PERIOD OF ONE (1) YEAR FROM SEPTEMBER 4, 2024 TO SEPTEMBER 3, 2025 IN AN AMOUNT NOT TO EXCEED \$210,000.00 – CC2020-07

WHEREAS, on December 7, 2023, Resolution No. 23-543 exercised the option to extend the contract with Trenton Health Team, Inc., 1 West State Street, 4th Floor, Trenton, New Jersey 08608 FROM SEPTEMBER 4, 2023 TO September 3, 2024 for Essential Public Health Services for the City of Trenton, New Jersey for a period of one (1) year in an amount not to exceed \$210,000.00 for the City of Trenton, Department of Health and Human Services, Division of Community Relations and Social Services; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Health and Human Services has determined that Trenton Health Team, Inc., 1 West State Street, 4th Floor, Trenton, New Jersey 08608 for Essential Public Health Services have been performed in a satisfactory manner and it is in the best interest of the city to exercise the option to extend the contract for an additional one (1) year from September 4, 2024 to September 3, 2025; and

WHEREAS, funds in an amount not to exceed \$210,000.00 have been certified to be available in the following account number: 5-01- -40-4023-290. This contract shall be awarded from September 4, 2024 to September 3, 2025, this is the final extension;

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to exercise the option to extend the contract for an additional one (1) year from September 4, 2024 to September 3, 2025 awarded to Trenton Health Team, Inc., 1 West State Street, 4th Floor, Trenton, New Jersey 08608 for Essential Public Health Services for the City of Trenton in an amount not to exceed \$210,000.00 for the City of Trenton, Department of Health and Human Services, Division of Community Relations and Social Services for the said purpose in the manner prescribed by law.

FOR ESSENTIAL PUBLIC HEALTH SERVICES FOR THE DEPARTMENT OF HEALTH AND HUMAN SERVICES FROM SEPTEMBER 4,
2024, TO SEPTEMBER 3, 2025

THE AGREEMENT made this 20th day of DECEMBER 2024, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **TRENTON HEALTH TEAM, INC., 1 WEST STATE STREET, 4TH FLOOR, TRENTON, NEW JERSEY 08608** (hereinafter "CONTRACTOR")

WHEREAS, on December 7, 2023 Resolution No. 23-543 awarded a contract to TRENTON HEALTH TEAM, INC., 1 WEST STATE STREET, 4TH FLOOR, TRENTON, NEW JERSEY 08608 for Essential Public Health Services for a period of three (3) years in an amount not to exceed \$210,000.00 with an option to extend two (2) one (1) year extensions in an amount not to exceed \$210,000.00 per year for the City of Trenton, Department of Health and Human Services; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Health and Human Services, has determined that TRENTON HEALTH TEAM, INC., 1 WEST STATE STREET, 4TH FLOOR, TRENTON, NEW JERSEY 08608 has performed Essential Public Health Services in a satisfactory manner and it is in the best interest of the city to exercise the option to extend the contract for an additional one (1) year from September 4, 2024, to September 3, 2025; and

WHEREAS, funds in the amount not to exceed \$210,000.00 to exercise the option to extend the contract for an additional one (1) year. The City of Trenton shall award this contract from September 4, 2024, to September 3, 2025.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor hereby authorized to exercise the option to extend the contract for an additional one (1) year from September 4, 2024, to September 3, 2025 to TRENTON HEALTH TEAM, INC., 1 WEST STATE STREET, 4TH FLOOR, TRENTON, NEW JERSEY 08608 in amount not to exceed \$210,000.00 for Essential Public Health Services of the City of Trenton, Department of Health and Human Services for the said purposes in the manner prescribed by law.
