**RESOLUTION AWARDING A CONTRACT THROUGH THE FAIR AND OPEN PROCESS  
IN ACCORDANCE WITH N.J.S.A. 19:44A-20.5, AND N.J.S.A. 40A:11-4 ET SEQ., TO JGSC  
GROUP LLC FOR THE CITY OF TRENTON BY AND THROUGH THE DEPARTMENT  
OF HOUSING AND ECONOMIC DEVELOPMENT, DIVISION OF ECONOMIC  
DEVELOPMENT TO HIRE A CONSULTANT TO ASSIST WITH BUSINESS  
ATTRACTION FOR A PERIOD NOT TO EXCEED ONE (1) YEAR FROM DATE OF  
AWARD IN AN AMOUNT NOT TO EXCEED \$150,000.00 PER RFP2024-20B**

**WHEREAS**, the City of Trenton (the "City") by and through the Department of Housing and Economic Development, Division of Economic Development has a need to hire a consultant to assist with business attraction for a period of one (1) year from date of award; and

**WHEREAS**, a Request for Proposal was advertised, and three (3) sealed proposals were received on October 8, 2024 at 11:00AM, by the Purchasing Agent, and were evaluated by a committee based on criteria that included, experience, understanding of requirements and cost; and

**WHEREAS**, the proposal of JGSC Group, LLC, 2845 Powell Avenue, Pennsauken, New Jersey 08110 was deemed to have the necessary qualifications and expertise for the performance of the services at the rates budgeted; and

**WHEREAS**, funds in an amount not to exceed \$150,000.00 have been certified to be available in the following grant account number: G-SS-25-60-320B-299 for a period not to exceed one (1) year from date of award.

**NOW, THEREFORE IT IS RESOLVED**, by the City Council of the City of Trenton, as follows:

1. The above recitals are incorporated by reference as if set forth at length herewith.
2. The Mayor is hereby authorized to execute a contract between the City by and through the Department of Housing and Economic Development, Division of Economic Development, and Division of Planning and JGSC Group, LLC, to hire a consultant to assist with business attraction, in an amount not to exceed \$150,000.00 for a period not to exceed one (1) year from date of award.

**PROFESSIONAL SERVICES CONTRACT**

**RFP2024-20C  
RESOLUTION 24-479**

**AWARDED TO JGSC GROUP, LLC TO HIRE A CONSULTANT TO ASSIST WITH BUSINESS ATTRACTION FOR  
A PERIOD OF ONE (1) YEAR FROM DATE OF AWARD**

**THIS CONTRACT** made this 6<sup>TH</sup> day of DECEMBER 2024 by and between the **CITY OF TRENTON, 319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** a Municipal Corporation of the State of New Jersey, ("City") and **JGSC GROUP, LLC, 2845 POWELL AVENUE, PENNSAUKEN, NEW JERSEY 08110** ("CONTRACTOR").

**WHEREAS**, the City has a need to **HIRE A CONSULTANT TO ASSIST WITH BUSINESS ATTRACTION** for the City of Trenton, Department of Housing and Economic Development.

**WHEREAS**, Contractor agrees to **HIRE A CONSULTANT TO ASSIST WITH BUSINESS ATTRACTION** for the City of Trenton, Department of Housing and Economic Development in accordance with the terms and conditions as set forth hereinafter, and the City being agreeable thereto;

**NOW THEREFORE**, the parties mutually agree as follows:

**TO HIRE A CONSULTANT TO ASSIST WITH BUSINESS ATTRACTION** for the City agrees to retain **JGSC GROUP, LLC, 2845 POWELL AVENUE, PENNSAUKEN, NEW JERSEY 08110** "the request of and under the general supervision of the City of Trenton, Department of Housing and Economic Development.

**1. SCOPE OF SERVICES**

**SEE ATTACHED SCOPE OF SERVICES**

**DURATION OF THE CONTRACT:**

This contract shall remain in full force and effect for a period of one (1) year from **DECEMBER 6, 2024, TO DECEMBER 5, 2025**, in an amount not to exceed **\$150,000.00**.

- 2. STATUS OF CONTRACTOR:** It is expressly understood by and between the parties hereto that the status of the Contractor retained to carry out the services set forth in this agreement is that of an Independent Contractor. It is further understood by and between the parties that is not intended, nor shall it be construed, that the contractor is an agent, employee, or officer of the City of Trenton.
- 3. NOTICES:** Any notices required to be delivered to either party pursuant to this Contract shall be in writing to their respective addresses. The parties shall be responsible for notifying each other of any change of address.
- 4. INTEGRATION: Resolution #24-479** and this contract constitutes the entire agreement between the parties and any representation that may have been made prior to the execution of this Contract are nonbonding, void, and of no effect and neither party has relied on any such prior representations in entering this Contract with the City of Trenton, Department of Administration, Division of Information Technology.
- 5. ENFORCEABILITY:** If any term or condition of this Contract or its application to any party or circumstances shall be deemed invalid or unenforceable, the remainder of the Contract and its application to other parties and circumstances shall not be affected.
- 6. GOVERNING LAW:** This Contract shall be governed by the laws of the State of New Jersey.

**MISCELLANEOUS PROVISIONS:**

- a. Contractor will not discriminate against any employee or applicant for employment because of age, race, creed, color, national origin, ancestry, marital status, sex, gender identity or expression, affectional or sexual orientation, disability or nationality. Contractor will take affirmative action to ensure that such applicants are recruited and employed and that employees are treated during employment, without regard to their age, race, creed, color, national origin, ancestry, marital status, sex, affectional, gender identity or expression, sexual orientation. Such action shall include, but is not limited to the following: employment, upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. Contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided by the Public Agency Compliance Officer setting forth provisions of this nondiscrimination clause;
- b. Contractor, where applicable will, in all solicitations or advertisements for employees placed by or on behalf of the Contractor, state that all qualified applicants will receive consideration for employment without regard to age, race, creed, color, national origin, ancestry, marital status, sex, gender identity or expression, affectional or sexual orientation.
- c. Contractor, where applicable, agrees to comply with the regulations promulgated by the Treasurer pursuant to P.L. 1975, c. 127, as amended and supplemented from time to time and the American with Disabilities Act.
- d. Contractor, where applicable, agrees to attempt to schedule minority and female workers consistent with the applicable county employment goals prescribed by N.J.A.C. 17:27-5.2 promulgated by the Treasurer pursuant to P.L. 1975, c. 127, as amended and supplemented from time to time or in accordance with a binding determination of the applicable county employment goals determined by the Affirmative Action Office pursuant to N.J.A.C. 17:27-5.2, amended and supplemented from time to time.
- e. Contractor, where applicable, agrees to inform in writing appropriate recruitment agencies in the area, including employment agencies, placement bureaus, colleges, universities, labor unions that it does not discriminate on the basis of age, creed, color, national origin, ancestry, marital status, sex, gender identity or expression, affectional, sexual orientation, disability or nationality and that it will discontinue the use of any recruitment agency which engages in direct or indirect discriminatory practices.
- f. Contractor, where applicable, agrees to review all procedures relating to transfer, upgrading, downgrading and layoff to ensure that all such actions are taken without regard to age, race, creed, color, national origin, ancestry, marital status, sex, gender identity or expression, affectional, sexual orientation, disability or nationality. Contractor will conform these employment goals consistent with statutes and court decisions of the State of New Jersey, and applicable Federal law and Federal court decisions.
- g. Contractor, where applicable, shall furnish such reports or other documents to the Affirmative Action Office as may be requested by the office from time to time in order to carry out the purposes of these regulations. Contractor shall furnish such information as may be requested by the Affirmative Action Office for conducting a compliance investigation pursuant to Subchapter 10 of the Administrative Code (N.J.A.C. 17:27).
- h. Contractor, shall submit along with the signed contract one of the following as evidence of compliance with N.J.A.C. 17-27:

1. Appropriate evidence that the independent contractor is operating under an existing Federally approved or sanctioned affirmative action program.
2. A certificate of employee information report approval issued in accordance with N.J.A.C. 17:27-4.
3. An initial employee information report (Form AA #302) provided by the Affirmative Action Office and completed by the contractor in accordance with N.J.A.C. 17:27-4
