THE AGREEMENT made this 20<sup>th</sup> day of SEPTEMBER 2024, by and between the CITY OF TRENTON, a municipal corporation, of the State of New Jersey, with principal offices located at 319 EAST STATE STREET, TRENTON, NEW JERSEY 08608 (hereinafter the "City") and GARY KUBIAK AND SONS ELECTRIC, INC., 12 SHARON ROAD, ROBBINSVILLE, NEW JERSEY 08691 (hereinafter "CONTRACTOR")

WHEREAS, on June 13, 2023 Resolution No. 23-268 awarded a contract to GARY KUBIAK AND SONS ELECTRIC, INC., 12 SHARON ROAD, ROBBINSVILLE, NEW JERSEY 08691 to provide On-Call Electrical Services and Repairs at Various City of Trenton Facilities for a period of one (1) year from date of award in an amount not to exceed \$60,000.00 (\$30,000.00 per vendor) with an option to extend the contract for two (2) one (1) year extensions in amounts not to exceed \$60,000.00 (\$30,000.00 per vendor) (2<sup>nd</sup> year) and \$60,000.00 (\$30,000.00 per vendor) (3<sup>rd</sup> year) for the Department of Public Works;

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (2) two one-year extensions; and

WHEREAS, on September 19, 2024 Resolution No. 24-404 exercised the option to extend the contract to GARY KUBIAK AND SONS ELECTRIC, INC., 12 SHARON ROAD, ROBBINSVILLE, NEW JERSEY 08691 to provide Third Party Administration Services, and it is in the best interest of the City of Trenton, Department of Administration to exercise the option to extend the contract for an additional one (1) year from June 1, 2024 to May 31, 2025; and

WHEREAS, funds in the amount not to exceed \$60,000.00 (\$30,000.00 per vendor) to exercise the option to extend the contract for an additional one (1) year. The City of Trenton shall award this contract from June 1, 2024 to May 1, 2025.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor hereby authorized to exercise the option to extend the contract for an additional one (1) year from June 1, 2024 to May 1, 2025 with GARY KUBIAK AND SONS ELECTRIC, INC., 12 SHARON ROAD, ROBBINSVILLE, NEW JERSEY 08691 in amount not to exceed \$60,000.00 (\$30,000.00 per vendor) for On-Call Electrical Services and Repairs at Various City of Trenton Facilities for the City of Trenton, Department of Public Works for the said purposes in the manner prescribed by law.
