**RESOLUTION ACCEPTING A BID AND AWARDING A CONTRACT TO
CALGON CARBON CORPORATION, FOR THE FURNISHING AND DELIVERY
OF POWDERED ACTIVATED CARBON FOR THE TRENTON WATER
FILTRATION PLANT FOR A PERIOD OF ONE (1) YEAR FROM DATE OF
AWARD WITH AN OPTION TO EXTEND ONE (1) ADDITIONAL YEAR IN AN
AMOUNT NOT TO EXCEED \$803,400.00 - BID 2023-70**

WHEREAS, one (1) sealed bid was received on October 19, 2023 in the Division of Purchasing at 11:00am by the Purchasing Agent, for the Furnishing and Delivery of Powdered Activated Carbon for the City of Trenton, Department of Water and Sewer, Water Filtration Plant for a period of one (1) year with an option to extend one (1) additional year; and

WHEREAS, powdered activated carbon is used to control taste and odor as well as reduce disinfection by-products in the water filtered through the Water Filtration Plant; and

WHEREAS, the sole bid of Calgon Carbon Corporation., 300 GSK Drive, Moon Township, PA 15102 is made pursuant to advertisement, be and is hereby accepted, as the lowest, responsible, responsive bidder complying with terms and specifications on file in the Division of Purchasing; and




